

How To Apply for A Consumer Loan

First, become a member. Second, have at least \$20.00 in your Share (Savings) account above the \$50.00 minimum for your application fee. Then, submit an application by:

1. Calling the loan department and we can take your application over the phone 412-205-5201.
2. Fill out, and sign the application [here](#) then email it to consumerlending@triboro-fcu.org, be sure to let us know what you need the funds for and that we have permission to transfer the \$20 app fee from your Share (Savings) or Draft (Checking) account.
3. Fax your completed and signed application to 412-460-4001.
4. After our office hours, you can call 866-363-1959 to submit a loan application with our Loan Center.
